## **Executive Director's** Report

n the Winter 2016 edition of *Siren* appears an article about the *fire alliance* model for delivering EMS services. A fire department that does not provide ambulance service (a traditional nontransport first-response service) partners with a private ambulance company; the partnership creates an alliance that qualifies the newly formed entity/partnership to submit a proposal to become an exclusive ambulance provider. Such an alliance in theory is financially beneficial to the public agency fire department because they now qualify to receive enhanced reimbursement levels for serving Medi-Cal patients.

The *fire alliance* model, in its purist form, has advantages and disadvantages for the private ambulance company partner. I believe that ultimately, the disadvantages outweigh the advantages, but the "jury is still out"; there are varying opinions.

Contra Costa County (CoCo County) used the *fire alliance* model in its exclusive ambulance selection process in 2015. The process used in CoCo County was seriously flawed. The CAA believed that the selection process did not provide all qualified ambulance companies a fair opportunity to compete for the exclusive ambulance contract. Consequently, the CAA filed a complaint in April 2016 with the California EMS Authority (EMSA), asking for a thorough investigation. The CAA's complaint including all attachments/ evidence exceeded 200 pages. Two years later, EMSA announced the findings of its investigation. The State's findings completely validate the CAA's complaint and concerns. In its letter of April 13, 2018, EMSA found, *"the process conducted by Contra Costa County EMS agency, in collusion with the Contra Costa Fire Protection District and*" the selected ambulance company, *"stifled competition due to bid rigging and was anti-competitive due to other factors related to the bid.*" As a result, EMSA has imposed a number of sanctions on CoCo County to correct the problems.

Had the CAA not intervened, and called "foul" over the improper actions in CoCo County, EMSA would probably not have taken the time to investigate this issue. If not for the CAA, who would have stepped forward? By the CAA taking this action, it demonstrates its commitment to its members to advocate for their interests and fight for level playing fields in exclusive contract competitions, statewide. Through this action, EMSA is reminding all counties and local EMS agencies in California to comply with the law. This is one of those examples of the CAA, working quietly behind the scenes, actively protecting the interests of its members; it is a perfect example of the intangible value of the CAA. 🗱

## Update On the 2018 Legislative Session

he 2018 Legislative Session is getting close to the midway point and it has been a very busy year so far for the CAA. With more than 2300 bills introduced this year, there are many that are of interest to CAA and its member companies. While many of these bills are problematic to us as employers in the State of California, there are also many bills that are specific to the ambulance industry in this state. The focus of this article is on the bills that are directed at EMS providers in this state.

SB 944 by Senator Bob Hertzberg is particularly problematic because the bill takes obvious sides in the perennial debate over public versus private EMS providers. Sponsored by the California Professional Firefighters, the bill gives a "right of first refusal" to public providers in jurisdictions that want to conduct community paramedicine programs in this state.

While the CAA has been strongly in favor of continuing the CP program (as it is scheduled to expire at the end of this calendar year), actually sponsoring a bill last year to do so (AB 1650 by Assemblyman Brian Maienschein), the approach taken by SB 944 is focused on giving the upper hand to public providers.

In the debate over SB 944, it is important to note that 71% of the patients served so far in the existing CP pilot programs are served by private ambulance companies. And, we provide 82% of the 911 transports in this state. Nonetheless, SB 944 would preclude or substantially limit the role of private EMS in the CP program in this state. The bill is pending in the Senate Appropriations Committee.

AB 1795 by Assemblyman Mike Gipson would allow a CP program focused on alternative destinations. This bill is sponsored by the County of Los Angeles and is actively supported by numerous groups, including the CAA. AB 1795 is strongly opposed by the California Nurses Association. CAA had taken a support, if amended position on this bill because we believe the CP program also needs to address the long-standing issue of provider reimbursement.

In light of valuable work recently done by Donna Hankins, the Chair of the CAA's Payer Issues Committee, the issue of reimbursement may be addressed by the Department of Health Care Services and so our Board recently took a full support position on the bill. The measure is pending in the Assembly Appropriations Committee.

AB 2436 by Assemblyman Devon Mathis would require the Department of Health Care Services to establish payment rates for ground ambulance transportation

services to be based upon the Consumer Price Index-Urban, which result in an important increase in Medi-Cal provider rates. The CAA is actively supporting this bill to ensure that the State's reimbursement rates cover more of the actual costs of providing transport services to the Medi-Cal population. This bill passed the policy committee and is pending in the Assembly Appropriations Committee.

AB 2293 by Assemblywoman Eloise Reyes concerns EMS licensure. The CAA is in the process of taking an oppose position on this bill. It would modify the criteria related to conduct that the EMS Authority may consider when denying an EMT's application. AB 2293 would also permit the EMS Authority to consider whether an applicant demonstrates substantial rehabilitation and extend the time for an applicant to file a notice of defense from 15 to 30 days in response to a denied EMT application.

In terms of the legislative calendar, June 3 is the house of origin deadline when all ABs need to pass the Assembly and all SBs need to pass the Senate. Thereafter, the process repeats itself in the other house before the Legislature's scheduled adjournment of August 31. Thereafter, the Governor will have until September 30 to act on legislation sent to his desk. \*

## 2018 CAA Stars of Life Awards Presented to Outstanding EMS Personnel

he CAA's annual *Stars of Life Celebration & Legislative Summit* was held on Monday, April 30, 2018 in Sacramento. Using the Sheraton Grand Hotel as the venue, just one block from the State Capitol, was convenient for legislative visits and fittingly elegant for the award winners.

Forty-two individuals received a *Star of Life*, and these people (*Stars*) represented 11 ambulance companies. See listing of awardees on the next page. *Star of Life* recipients were recognized for a range of achievements, including bravery and heroism, saving lives, clinical excellence, service excellence, leadership, and being the best at what they do. Each individual story of each Star is inspiring, and the work they have performed serves as a small example of the great service being delivered by the private ambulance industry in California every day.

Michael Petrie, president of Emergency Medical Services Administrators' Association of California (EMSAAC), and EMS Chief in Monterey County, gave the keynote address on Monday morning to the attendees. Petrie's address covered a range of relevant topics on EMS from the "street" perspective. His inspiring words put context to today's elderly and frail as being yesterday's movers and heroes, who deserve our respect. Attendees very much appreciated Petrie's insightful message.

Midday was spent visiting and meeting with legislators. Stars got the opportunity to share their stories with the State's political leaders. Several of the Stars were given VIP tours of the Capitol, and all of the *Stars* sitting in the chamber gallery of each house of the legislature were recognized by the Assembly and Senate. The key legislative messages delivered by the Stars and their company hosts were: Support AB 2436, proposing an across the board increase in Medi-Cal reimbursement rates for ambulance services; Support AB 1795, the community paramedic bill authorizing alternate destinations; and Oppose SB 944, which proposes to give public agencies/fire departments several advantages over private ambulance services.

Senator and Dr. Ed Hernandez (Dr. Ed) gave the keynote address during the evening awards ceremony. Dr. Ed has been a longtime supporter for improving Medi-Cal reimbursement rates for ambulance service. Additionally, he authored SB 1300 in 2016 to create the emergency ambulance QAF, which was vetoed by the Governor. In 2017, he authored AB 523 to again create the emergency ambulance QAF, and this bill successfully became law; Medi-Cal rates for emergency ambulance service are expected to increase dramatically this year. This is Dr. Ed's last year as a senator, due to term limits; he is currently running for Lt. Governor.

Assembly member Heath Flora also spoke at the evening awards ceremony. He is a freshman legislator from Modesto, and was a firefighter and paramedic. With his experience as a first-responder and medic, it is easy for him to understand the private ambulance industry's struggles – our world is real to him. Assemblyman Flora authored last year's AB 817, the CAA-sponsored bill to address employee rest periods.

Senator Hernandez and Assemblyman Flora participated in the awards ceremony and awarded each Star with an official certificate of recognition from the Senate and Assembly. The CAA thanks and greatly appreciates the participation and support both of the legislators have shown in being part of the Stars of Life celebration.

The annual Stars of Life celebration is one of CAA's signature events of the year. It is an expensive endeavor, and it would not be possible without the support and generous contributions from our sponsors. We thank, and we encourage you to thank,

## **Overview of California's Budget Process**

he state budget process on paper is similar to the legislative process; however, it can be different in practical terms. The full budget committees of the Senate and Assembly act mostly as the final arbiter of their respective houses when it comes to finalizing the actions of their subcommittees.

#### PARTS OF THE BUDGET

The following are the main parts of the California state budget:

- **Budget Bill** This contains the appropriations and "Budget Bill Language." Note that only a Budget Bill can contain multiple appropriations. It requires a majority vote for passage and the bill takes effect immediately.
- **"Budget Bill Jr."** This is the bill that amends the main Budget Bill.
- **Trailer Bill** This bill makes the statutory changes needed to implement the budget. It is the same as any other bill, but it takes effect immediately with a majority vote if it contains an appropriation related to the budget bill and is listed as a "trailer bill" in the budget bill.
- Supplemental Report This is a separate report that requests specific actions from state agencies and departments. It does not have the force of law.

#### Timing

Keep in mind the following three dates:

- January 10 Constitutional Requirement for Governor to propose the budget.
- June 15 Constitutional Requirement for Legislature to pass the budget.

• July 1 – Fiscal Year begins.

The Assembly Budget Committee and the Senate Budget and Fiscal Review Committee are charged with adopting the state budget and the respective trailer bills. Once the Governor's budget proposal is released by January 10, both budget committees' staff prepare a summary overview of the Governor's budget; a similar document is prepared by the Legislative Analyst Office (LAO).

In early March, the Assembly and Senate subcommittees begin holding hearings and taking testimony from the Department of Finance (DOF), LAO, respective state agencies and departments, and members of the public. This is a critical time to advocate for your client's position on specific budget requests. Most of the work on the budget occurs at the subcommittee level.

Prior to these hearings, the budget committee staff members examine the budget proposals and prepare agendas that include an explanation of the Governor's budget proposals and the staff's recommendations whether to accept, modify, hold open, or reject the budget proposals. Sometimes the Governor's budget proposals are "held open" for further discussions. The minority party staff prepare similar information for their members.

By the time the Governor's May Revise of the budget is released in mid-May, after April tax receipts are known, the subcommittees must conclude their deliberations within two weeks or so. As such, it is hard for the public to have much more input unless there is an entirely new budget proposal. As a result, it is important that communication be done early in the budget process.

#### **RECONCILING DIFFERENCES**

Differences between the actions of the Assembly and Senate are usually handled by a 2-house conference committee. The procedural requirements have sometimes been waived due to time constraints for establishing the budget conference committee. The Assembly and Senate rotate the chairmanship of the conference committee each year.

This process is supposed to address the differences between the versions of the budget adopted by the Senate and Assembly. While the conference committee is open to the public and usually broadcast on California Channel, usually there is no public testimony taken. Instead, advocates rely upon budget conferees to advocate for a position adopted by one house.

The three Assembly Members and three Senators (4 Democrats and 2 Republicans) hear from the DOF and the LAO, and deliberate among themselves. The conference committee will sometimes make changes known as "conference compromises." After that, they will finalize the remaining items and close-out the budget.

Thereafter, both houses will vote on the conference report and they will pass budget trailer bills. Again, once the budget is on the floor, there is little opportunity to make changes. Sometimes there will be an opportunity to modify policy language contained in a trailer bill, or some budget line items are modified in a "budget junior" bill.

#### PREPARING THE BUDGET

State departments must submit their budget proposals to their respective agencies, who in turn submit their proposals to the Department of Finance. This occurs in the early fall. After the DOF makes its recommendations, the Governor and his staff will make final determinations in consultation with DOF in time for release of the Governor's budget by the January 10 deadline.

The Governor's budget is on the DOF website under the E-BUDGET tab. The budget is over 1,300 pages in length and contains the details of the Governor's proposed budget spending for the upcoming fiscal year. Each budget item is assigned a 10-digit code and includes the state department, purpose and funding source.

The legislative budget subcommittees (which are known by numbers in both the Assembly and Senate) have the following subject matter jurisdictions:

- Education (Senate Subcmte #1 and Assembly Subcmte #2)
- Resources, Environment, and Transportation (Senate Subcmte #2 and Assembly Subcmte #3)

- Health and Human Services (Senate Subcmte #3 and Assembly Subcmte #1)
- State Government (Senate Subcmte #4 and Assembly Subcmte #4)
- Public Safety and Judiciary (Senate Subcmte #5 and Assembly Subcmte #5)

#### **BUDGET PHRASES**

State agencies submit "budget change proposals," often referred to as BCPs, which contain proposed expenditures and budget changes to existing levels of service that are used to prepare the Governor's budget. These BCPs can be reviewed on the DOF website.

This is distinguished from a "deficiency" request wherein an agency or department has an unanticipated increase in its costs (regardless of reason) that exceed the funding that was appropriated for the agency or department in the state budget. In these cases, the agency or department will request a deficiency appropriation in separate legislation.

Budget control language (BCL) is language contained in the budget bill that provides conditions on the use of a specific appropriation contained in the budget. There are also "Finance Letters" which are proposals made by the Director of Finance to the chairs of the budget committees in each house to amend the Budget Bill and the Governor's Budget from the form submitted by January 10 in order to reflect a revised plan of expenditure.

#### **BUDGET PHASES**

The following slides describe the six distinct phases of the budget process:

- Phase 1: Study Phase (November – February)
- Phase 2: Public Participation/ Listening Phase (March – Mid-May)
- Phase 3: Action Phase (Mid-May to End of May)
- Phase 4: Negotiation Phase (June 1 to June 10)
- Phase 5: Vote and Signing Phase (June 15 – June 27)
- Phase 6: Follow-up and Clean-up Phase (July – September) \*

## Vote for the Emergency Ambulance Initiative in November

hen you receive your ballot this November, you will be asked to decide on numerous candidates and propositions. But there is one measure – the Emergency Ambulance Employee Safety and Preparedness Act – that the California Ambulance Association supports and should have your vote as well.

As California's first responders, you know better than anyone how important it is to respond quickly to 911 emergency calls. Often times, seconds can mean the difference between life and death.

That is the heart of the issue with the Emergency Ambulance Employee Safety and Preparedness Act. The initiative establishes into law the longstanding industry practice of requiring public safety personnel to remain reachable during their breaks and it pays private EMTs and paramedics to do so. This guarantees that public safety will not be compromised and when a patient needs 911 emergency care, an ambulance will not be delayed or prevented from responding.

In fact, much like other essential emergency personnel, private emergency ambulance providers have always operated this way to ensure fast responses and the delivery of lifesaving pre-hospital care.

Unfortunately, a recent California Supreme Court decision dealing with rest breaks for private security guards stated that they must be relieved of all duties during those breaks. If applied to the private emergency medical service (EMS) industry, the impact would be detrimental to private EMS operators and place patient care at risk. Over the last couple years, California has seen an unfortunate rise in mass casualty incidents and natural disasters, and 911 emergency medical care is not something that can afford to wait or be put on pause.

With the recent Southern California mudslides, devastating wildfires and other looming natural disasters, as well as the threat of active shooter incidents, it is more important than ever that EMTs and paramedics can respond immediately to protect and save patients. The initiative recognizes these public safety threats and ensures emergency ambulance crews will be trained annually for handling emergency incidents just like these.

In addition, the initiative also helps prepare EMTs and paramedics both mentally and physically for emergencies. These jobs can often be emotionally taxing, as EMTs and paramedics witness traumatic incidents sometimes on a daily basis. The initiative ensures emergency medical crews are provided with annual mental health and wellness training, as well as mental health coverage. It also prevents breaks from being taken back-to-back or all at once, to make sure EMS employees receive relief when they need it most.

We all know that emergencies aren't predictable – that is why it is so critical to be prepared at a moment's notice. The initiative also says that if emergency medical crews miss a break and it cannot be made up during the work shift, they will receive additional compensation. This is a commonsense reform. Plus, the nonpartisan Legislative Analyst's Office found in their independent analysis of the initiative that the measure would actually save local governments tens of millions of dollars annually due to lower ambulance provider costs reflected in agency contracts. This means local governments will have more money for other essential services, like libraries, parks and police.

This November, please support the Emergency Ambulance Employee Safety and Preparedness Act to ensure 911 emergency care will not be delayed. **\***
