The images of a multi-vehicle car crash with bodies strewn across the Sierra High School football field in Manteca seemed all too real. And that's just what emergency workers were hoping for. Once again Manteca District Ambulance joined with other first responders to present their city-wide "Every 15 minutes"



program which is geared towards showing students and parents alike what the consequences of drinking and driving can be.

The two-day event consisted of a grim reaper visiting senior classrooms to summon the "walking dead" while a Manteca police officer read their death notices to class mates. "Drunk drivers" were ordered to appear in court and a memorial service drew a crowd of over 2,300 students, parents and first responders.



New Funding Mechanism Being Evaluated

During these uncertain times, CAA members are focusing on delivering the highest quality services to their patients and communities within a tougher financial climate. Your association management team is also focusing on meeting members' priority needs for information and education on critical industry issues. In addition, the association is sharpening our focus on the very important strategic priority for a Medi-Cal rate increase.

In addition to the CAA's legislative goal for a Medi-Cal rate increase, the CAA is also

concerned about protecting against another Medi-Cal rate decrease and achieving recognition of ALS level of care. Recently, a new funding mechanism has been proposed which would establish a provider fee paid to the state which is then matched by federal dollars and is returned to ambulance providers through increased Medi-Cal rates. This proposal is based upon a similar program recently established for SNFs. A Medi-Cal Provider Fee Work Group has been formed to research the issue including an analysis of the policy options under consideration, the amount of a possible rate increase and the potential advantages and disadvantages for ambulance providers. Members are encouraged to attend the CAA 61st

Annual Convention where the work group will present an update to members and host a forum for members to have input on the funding options for a Medi-Cal rate increase. Each registered attendee at the convention will receive a FREE CD which contains a template specifically designed for ambulance providers to analyze the individual impact of various proposals. There will also be a legislative update regarding the prospects for a Medi-Cal increase in the face of the state's severe budget crisis.



hirty-six paramedics, EMTs and emergency medical dispatchers from across the state of California were recognized as Stars of Life at the state Capitol on March 18, 2009. Their actions, whether from a single life-saving event or a career-long exemplary performance record demonstrates they have stood out among their peers as the best of the best among California's private ambulance providers.

Their stories demonstrate the courage, discipline and skill needed to remain calm under pressure while delivering basic and advanced life support care in the field. Among those being honored are: Paramedic Max Baldridge who responded to a motor vehicle crash in Napa where he performed an advanced scope of practice skill called a "Needle Decompression" to relieve the pressure within the chest cavity and create an exchange of air—allowing his patient to breathe.

Paramedic Jim Clark and his EMT partner, Tina Fantozzi were dispatched to evacuate an injured firefighter during the Humboldt Fire in Butte County. When the engine company was unable to evacuate the injured firefighter due to fire activity, the EMS crew drove their ambulance down the dozer line, with fire on each side, to rescue the firefighter. By doing so, they were able to prevent unnecessary pain and delay in treatment of a fellow public safety member.

Eight EMS professionals from Vallejo are being commended for their excellence in service during a fire at an elderly- Assisted Living Facility in Vallejo that displaced over 100 residents and sent 36 people to the hospital.

Paramedic Michael Wallace responded to an injured person on a roof in Blythe where he found his patient trapped with a semi-detached arm. The patient was under an air conditioning unit which was attached to a crane that had tipped over. Mike's professionalism and actions in aggressively coordinating his patient's successful evacuation from the rooftop, prompt air ambulance resources and assuring trauma center orthopedic standby services were activated contributed to his patient's arm being saved. The Stars of Life event got off to a great start when KCRA did a live shot recognizing our Stars of Life during its morning news program. Shortly thereafter, the honorees were presented with their Stars of Life medals and pins. Afterwards, the 36 Stars and two dozen Hosts,

participated in over 50 meetings with legislators and staff at the state Capitol. In addition to having our Stars meet their respective Assembly Members and Senators at the State

Capitol, we used the opportunity to state our support for AB 1174 (Hernandez), which would increase Medi-Cal provider rates for ambulance companies. Our bill passed out of the Assembly Health Committee on Tuesday,

April 21. Please contact your legislators and let them know of your strong support for this important legislation.

Assemblyman Jerry Hill (D-San Mateo). He is the Chairman of the Assembly Budget Subcommittee # 1 which handles all state spending in the health and human services areas. At dinner, we enjoyed a keynote address from Assemblyman Nathan

Fletcher (R-San Diego). He is the Vice Chair of the Assembly Health Committee, the policy committee which will also consider our sponsored bill, AB 1174. After his address, our Stars were presented with a legislative

resolution from State Senator Roy Ashburn (R-Bakersfield), who has been a consistent supporter of CAA and its legislative agenda.

CAA Legislative Update

Numerous Legislative Items of Interest for CAA Members

Since our successful Stars of Life program in March at the State Capitol, we have been busy working on numerous pieces of legislation of interest to California's ambulance industry. As you can imagine, our priority legislation is our sponsored bill, AB 1174 by Assemblyman Dr. Ed Hernandez. That bill enjoyed a unanimous, bi-partisan vote out of the Assembly Health Committee in late April, and the bill is pending on the Assembly Appropriations Committee's "Suspense File," where it will be voted upon in late May. Thereafter, it will need to clear the full Assembly by early June.

As you probably know, AB 1174 would create the Ambulance Payment Reform Act of 2009 to substantially increase the amount of Medi-Cal reimbursements to ambulance providers in our state. In addition, the bill would create a CPI to ensure that those increased rates continue to reflect increases in inflation. Additionally, the bill would create a "prudent layperson" standard to ensure that all emergency transports, even if theyturn out not to be a medical emergency, are reimbursed as such, similar to the treatment offered to hospital emergency departments.

As you can see from our strong vote last month, we have been delivering a very strong message to legislators and their staff, as well the Governor's Office and Department of Health Care Services (DHCS). They appreciate that we are unique among underpaid Medi-Cal providers in this state, including our requirement to serve all patients, regardless of their ability to pay, with a specified time period. No other provider faces the same requirements as our industry does.

In addition to our sponsored bill, we have become heavily involved with Assemblyman Hector de la Torre's bill, AB 511, which would create a quality assurance fee for ambulance providers within the Medi-Cal program. Under current law, there is a "QA fee" program for skilled nursing and intermediate care facilities. Like ambulance providers, the hospitals are sponsoring a bill by Assemblyman Jones to create a similar "QA fee" program for hospitals serving Medi-Cal patients.

This effort is very labor intensive and CAA has created a work group to negotiate the parameters of such a program, including the actual statutory language and the required economic modeling. Assuming we are able to pass this legislation later this session, the program will have to be approved by the federal CMS. As Assembly Health Committee Chairman Dave Jones stated to us publicly, a provider fee is the other way at this point for us to obtain any Medi-Cal rate increases.

In addition, we are working with a number of Medi-Cal providers on Assemblyman Jim Beall's AB 613, which attempts to tackle the problems associated with treatment authorization requests (TARs). As you know, TARs are used as a method of utilization control under the Medi-Cal program, which is basically approval by the DHCS in advance of the rendering of services based upon medical necessity. The Assemblyman hopes to streamline the TAR process in several ways, including performing a cost-benefit analysis for each TAR and actually reducing the numbers of TARs required.



We have also been closely monitoring AB 538 by Assemblyman Juan Arambula. His bill attempts to combat instances of 911 emergency call abuses by allowing an entity that provides emergency services to report a violation to the public safety entity that received the 911 call so that the entity receiving the call can issue applicable warnings and citations for those who abuse the system.

We have been supporting a bill that Assemblyman Jerry Hill is carrying (AB 1272) that he spoke with CAA about at our March convention in Sacramento. Essentially, AB 1272 attempts to preclude a county from prohibiting a trauma care center from installing a helicopter landing pad at or near its facility for the purpose of receiving emergency trauma care patients.

Finally, we have been actively supporting SB 159 by Senator Joe Simitian which would repeal the sunset date of his "move over" law. The current January 1, 2010 sunset date is on his prior law which requires a person driving a vehicle on a freeway that approaches a stationary emergency vehicle displaying emergency lights to move over and pass with due caution.

Medi-Cal Rate Increase Funding Options State Fund Safety Awards

The CAA has sponsored legislation that would significantly increase Medi-Cal rates. However, the long-term fiscal and political realities caused by the state budget crisis pose a very large hurdle. In addition to the CAA's legislative goal for a Medi-Cal rate increase, the CAA is also concerned about protecting against another Medi-Cal rate decrease and achieving recognition of ALS level of care. A new funding mechanism has been proposed which would establish a provider fee paid to the state which is then matched by federal dollars and is returned to ambulance providers through increased Medi-Cal rates. This proposal is based upon a similar program recently established for SNFs. Members of the CAA's Medi-Cal Provider Fee Work Group will present an update on their research on the issue including an overview of policies under consideration, the amount of a possible rate increase and potential advantages and disadvantages for ambulance providers. The work group will also present a template (each attendee will receive the template FREE on a CD) for ambulance providers to analyze the individual impact of various proposals.

Think Safety

How's Your New "Sprinter"?

Many ambulance providers have made the switch from the traditional Ford Van to the Dodge "Sprinter" ambulance. While the economics of operating a Sprinter have been the primary reason for making this change, i.e., 18 MPG (Sprinter) versus 10 MPG (Ford Van) there is also a little discussed safety benefit – the six point restraint system for the paramedic in the rear ambulance compartment. This is now standard equipment on the Sprinter.

Studies have been conducted over the last several years to identify opportunities to enhance safety practices yet real change in equipment, vehicle modifications and care practices has been dismally slow. Serious risks factors identified are unrestrained occupants, less than optimal seating configurations and placement, being struck by unsecured medical equipment or worse striking another person and hostile interior surfaces in the ambulance interior.

There is a myth in our industry, which contrasts with the data, that an ambulance vehicle is safe. USA Federal transportation databases record approximately 5,000 ambulance crashes annually, of which 10-15% are categorized as major crashes. Yet, many of us will not use the seatbelt or safety harness in the patient care compartment. "I feel too constrained while attending to patient care", is a common complaint.

I was recently asked by a 17 year old "When do you know you are old"? I think someone is old when they resist change just because it's a change.

Let's give the six point restraint a chance.



Take home message: 1. Drive cautiously. 2. Wear your seat belt and restrain all occupants 3. Secure all equipment.
